**BEING A RESOLUTION CERTIFYING THE RESULTS OF THE NOVEMBER 5TH, 2024
GENERAL ELECTION**

WHEREAS, THE 2024 NATIONWIDE GENERAL ELECTION WAS HELD ON NOVEMBER 5TH, 2024 WHICH INCLUDED CONTESTS FOR CITY OFFICES; AND

WHEREAS, THE CITY COUNCIL OF PINE ISLAND ACTS GENERALLY AS THE CANVASSING BOARD TO CERTIFY THE RESULTS OF CITY ELECTIONS IN 2024 FOR THE OFFICE OF THE MAYOR AND COUNCIL MEMBERS; AND

WHEREAS, 2,238 PEOPLE VOTED IN THE CITY GENERAL ELECTION WITH A TOTAL OF 2,509 REGISTERED VOTERS AS OF 7:00 AM ON ELECTION DAY, WITH 210 PERSONS REGISTERED ON ELECTION DAY AND 335 REGULAR, MILITARY, AND OVERSEAS ABSENTEE AND MAIL BALLOTS ACCEPTED.

NOW, THEREFORE, BE IT RESOLVED THAT THE PINE ISLAND CITY COUNCIL, ACTING IN ITS CAPACITY AS THE CITY'S CANVASSING BOARD, CERTIFIES THAT THE ATTACHED ABSTRACTS ARE A TABULATED STATEMENT AND A LIST OF THE NUMBER OF VOTES CAST FOR EACH PERSON IN THE CITY GENERAL ELECTION HELD ON NOVEMBER 5TH, 2024, IN THE CITY OF PINE ISLAND, MINNESOTA.

BE IT FURTHER RESOLVED THAT DAVID FRIESE PREVAILED IN THE CONTEST FOR MAYOR WITH 97.77% OF THE VOTES CAST AT 1,757 AND WAS ELECTED; THAT COLTON WRIGHT PREVAILED IN THE CONTEST FOR COUNCIL MEMBER WITH 49.33% OF THE VOTES CAST AT 1,324 AND WAS ELECTED; THAT VERNON PAHL PREVAILED IN THE CONTEST FOR COUNCIL MEMBER WITH 49.22% OF THE VOTES CAST AT 1,321 AND WAS ELECTED.

PASSED AND ADOPTED THIS 13TH DAY OF NOVEMBER 2024 BY THE PINE ISLAND CITY COUNCIL.




